## WCRMHC Ride and Campout Rules

For your safety and pleasure, we ask that you follow these rules, use common sense and show courtesy and consideration towards others at all times

Please leave sick horses at home, A horse with a noticeable cough, runny nose or any other potentially other communicable illness may be asked to leave.

If your horse kicks indicate that with a red ribbon attached to its tail. If leaving the group during the actual ride, advise the ride leader.

If riding within a private ranch or public or private park, follow all park rules and directions of ride leaders or park officials/rangers without question. You are a representative of our club and must represent us in the best possible way. Failure to comply will be cause for rescinding your club membership.

No loose horses are permitted in camp or on the trails. Hobbled horses are considered loose horses.

When riding through/in camp or at staging areas remain at the walk.

Dog Rules MUST be followed. No dogs are allowed on “day” rides unless otherwise stated in ride instructions. Some campsites do allow dogs. Be sure you know their rules in advance of bringing your dog. When in camp, dogs and other pets must be confined or leashed. Owners are responsible for their pet’s behavior. Pick up after your pet. Bring “doggie-doo” bags with you and use them, then deposit them in a trash receptacle. Dogs are NOT allowed in any group eating area.

Do NOT litter. Place all trash in a trash receptacle. No alcohol or firearms permitted on the trail.

Smoking is allowed only in designated areas. Absolutely NO SMOKING on the trail or in dry or forested locations.

Junior Riders (18 and under) are required to wear a helmet when on the horse at all times.

When camping observe quiet hours. No generators prior to 7 am or after 10 pm.

**I agree I will indemnify and hold harmless WCRMHC, its officers, directors, members and agents against all claims, demands and causes of action, including court costs and actual attorney fees arising from any proceeding or lawsuits brought by or prosecuted for my benefit, in which this release is upheld.**
